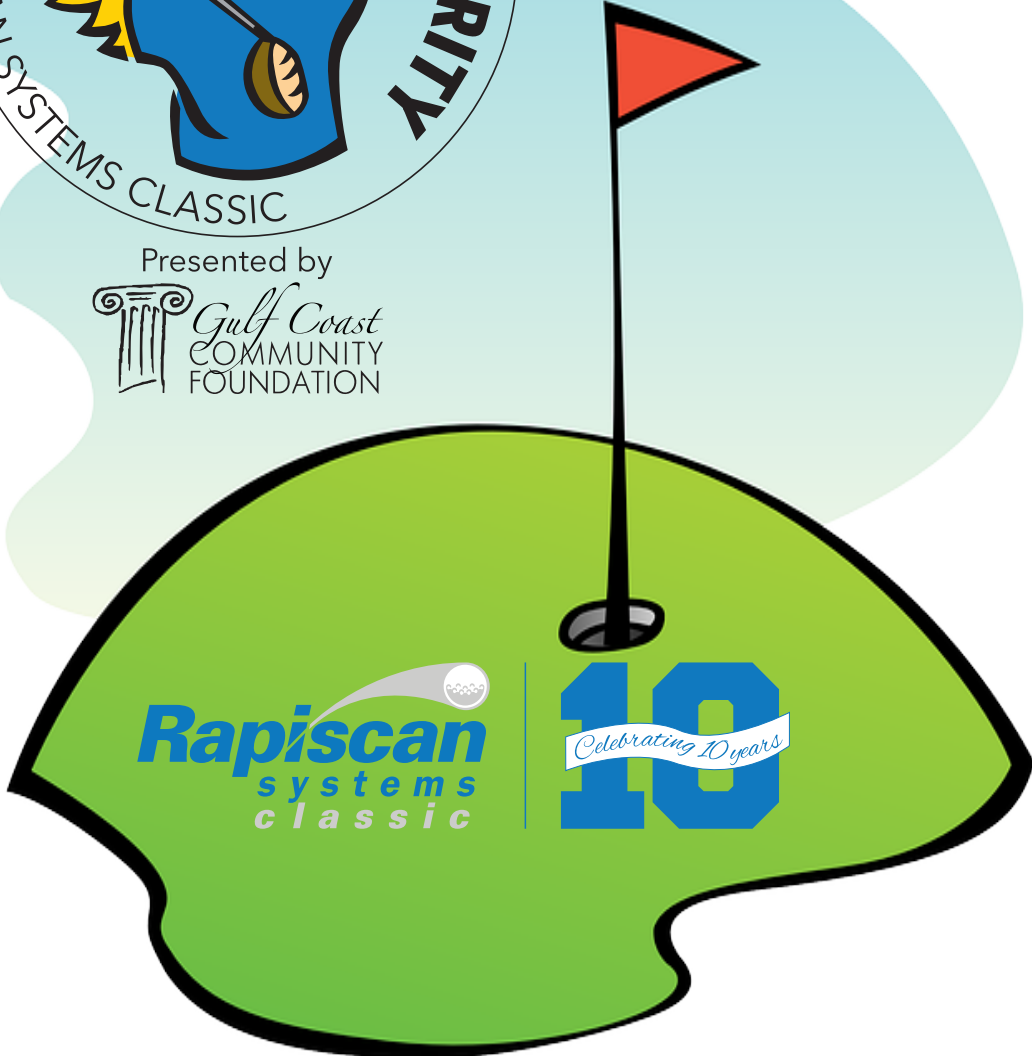

Program Facts

- Birdies for Charity® is a non-profit, tax-exempt 501(c)3 corporation established in the state of Iowa.
- The Corporation was formed for the purpose of licensing the Birdies for Charity® program to interested tournaments on the PGA TOUR, TOUR Champions, Nationwide TOUR and LPGA TOUR, to establish rules and regulations to be followed by licensees and to oversee compliance.
- Birdies for Charity® is a registered trademark of Birdies for Charity, Inc. unauthorized use of the name and/or logo is strictly forbidden.
- The Corporation has no direct affiliation with the Champions TOUR, the sanctioning body of professional golf tournaments on the “regular PGA TOUR, the Champions TOUR and the Nationwide TOUR, or the LPGA TOUR.”
- Participating tournaments enter a licensing agreement with the Corporation and agree to abide by the specific rules established for the Birdies for Charity® program.
- The Corporation has no direct involvement in the Birdies for Charity® program launched by a tournament. They do not fund the program on a local basis, nor do they share in the proceeds raised by the sponsoring organization or participating charities.
- A nominal licensing fee is paid by the sponsoring organization – in this case, Rapisan Systems Classic, has the right to conduct a Birdies for Charity® program.

Program Summary

Birdies for Charity® is a multi-level fundraising program designed to give participating charities the opportunity to generate contributions for their organization based on the number of “birdies” made by PGA TOUR Champion players Friday through Sunday during the Rapisan Systems Classic.

The program has three primary components:

- Solicitation of pledges from individuals and/or corporations
- “Guess the Birdies” contest
- Bonus Bucks and Matching Funds
- Participating charities will solicit pledges of three (3) cents or more from the general public and/or corporate donors for every “birdie” made or donors can make a flat donation of \$10 or more.
- In golf, a “birdie” is a score of one stroke better than “par” for any golf hole on the golf course. “Par” is the normal expected score of a golf professional on any given hole.

- It is expected that 700-800 birdies will be made by the PGA TOUR Champions Professionals (Friday through Sunday) of the tournament.

Pledge Solicitation

- Each participating charity has the opportunity to solicit pledges from individuals and/or corporations. Rapiscan Systems Classic will not solicit pledges for any participating charity.
- The following example shows how the value of a single pledge is calculated:
 - Example:
 - Individual Pledge \$.03 per birdie x 750 birdies = \$22.50 pledge
 - Corporate Pledge - \$3.00 per birdie x 750 birdies = \$2,250 pledge

100% of the pledges collected will go to the individual charity that solicited the Birdies for Charity® pledge. Administrative and promotional costs for the program will be paid by Rapiscan Systems Classic. (Excluding individual charity organization mailing/solicitation expense)

Deadline to Enter Guess the Birdies Contest: **March 29, 2019, 12:00 PM CST**

Donation Deadline: **May 17, 2019, 12:00 PM CST**

Collection Deadline for Payment: **May 30, 2019, 12:00 PM CST**

Special Events

Charities have the opportunity to hold special events with the proceeds from the event going towards their Birdies for Charity goal. All special events must be approved by the tournament's Birdies for Charity program manager before the event. It must be clearly noted at the event that the proceeds go towards the charity's Birdies for Charity goal.

“Guess the Birdies” Contest

- To create additional excitement for the program, the Rapiscan Systems Classic sponsors a “Guess the Birdies” contest. Participants who commit to a minimum pledge or donation on a completed official pledge form are eligible to guess the number of birdies that will be made by PGA TOUR Champions players Friday through Sunday of the Rapiscan Systems Classic. A pledge or donation is not necessary to play “Guess the Birdies” Contest.
- The total number of birdies will be calculated to include all “Birdies” made by PGA TOUR Champions players on Friday through Sunday at the Rapiscan Systems Classic.

- The “Guess the Birdies” contest entry form will be included on the official Birdies for Charity pledge form as well as the online form. Participants must submit their guess for the “Guess the Birdies” contest when submitting pledge form or when pledging online.
- Only guesses on pledge forms submitted before **March 29, 2019 at 12:00 PM CST** will be entered into the contest.
- The **2019 Grand Prize** is a two (2) night stay at Beau Rivage, a round of golf for two (2) at Fallen Oak and a \$200 food and beverage credit.

The Grand Prize will be awarded to the individual who correctly guesses the exact number of birdies made during the tournament. In the case of a tie, the Grand Prize winner will be determined by a random drawing between participants. If no individual guesses the correct number, the Grand Prize will be awarded to the person who comes closest (without going over) to the total.

Bonus Bucks and Matching Funds

BONUS BUCKS: Rapiscan Systems Classic will donate Bonus Bucks to the top three performing charities during the 2019 Birdies for Charity program. *Bonus Bucks will be based on the number of pledges actually collected, not the amount pledged.*

The cut-off date for the collection of all pledges is 12:00 PM CST on May 17th. After that date, we will determine the top three charities based on their collected amount. We will include the bonus bucks along with their final check, which will be distributed in June.

Top Four Charities:

1st place – receives **\$3000***

2nd place – receives **\$2000***

3rd place – receives **\$1000***

*Bonus Bucks are paid based on a charity’s total pledges **paid**, not on the total pledges made. Top 3 charities Bonus Bucks will be matched up to the winning amount. If raised funds are lower than winning amount, Bonus Bucks will be paid up to amount raised.

MATCHING FUNDS: Participating charities can earn additional bonus funds with our Matching Funds. Organizations that raise \$500 or more will receive a guaranteed match of a minimum of 5% on every donation they collect up to \$100,000. The program will match a total of up to \$480,000 raised by all charities. This amount and percentage can increase if additional matching funds are received.

Payment of Donations

The Rapiscan Systems Classic will distribute checks to each charity by the 15th of each month for donations collected the prior month if paid donations total more than \$100.00. Any remaining funds will be paid in a final check at the official check presentation ceremony in June.

Pledge Solicitation Rules & Regulations

- 1.) Participating charities must not solicit pledges in advance of the official pledge period as defined by the Rapiscan Systems Classic. You may notify your constituents via normal communication (ex: newsletter) that you are participating in Birdies for Charity®, but may not directly or indirectly request a pledge be made in advance of the official period. Failure to abide by this provision will result in expulsion from the program.
- 2.) Limited use of trademarks of Birdies for Charity® and Rapiscan Systems Classic will be granted to all participating charities. Samples of materials bearing the trademarks must be submitted to Rapiscan Systems Classic prior to distribution.
- 3.) Unauthorized use of the trademarks of Birdies for Charity® and the Rapiscan Systems Classic is strictly prohibited, and is grounds for expulsion from the program.
- 4.) The participating charity is responsible for the collection and submission of all completed pledge forms to Rapiscan Systems Classic. Rapiscan Systems Classic is not responsible for any pledge cards not received by the established deadline. Pledge forms that come in without the appropriate signature will be returned and not processed.
- 5.) **The official “Online Kick-Off” is Wednesday, January 23, 2019.** Once this date passes, the charities may start turning in their pledges to Rapiscan Systems Classic. The cut-off date for donations is **May 17th, 2019 12:00 PM CST.**

6.) Payments from Rapiscan Systems Classic will be equal to 100% of the value of collected pledges. No payment will be made on uncollected pledges. Payments made over and above the pledge amount on individual pledges to a charity will be paid to that

charity. (Example: person pledges \$.03 per birdie x 750 birdies = \$22.50 pledge. Person submits payment for \$25.00. Charity will be paid the higher amount).

7.) Rules may be amended at any time at the sole and absolute discretion of Rapiscan Systems Classic.

8.) Payment of pledges is to be made to Rapiscan Systems Classic and not the soliciting charity. Rapiscan Systems Classic will make payment to the participating charities of all collected pledges earned by that charity. After the established deadline, a listing of all uncollected pledges will be provided to each charity organization.

All donor information shall be protected and will remain confidential and the property of the charity. The Mississippi Gulf Resort Classic Foundation shall not solicit or use this information for any commercial purpose.

“Guess the Birdies” Rules & Regulations”

1.) **NO PLEDGE, PURCHASE OR DONATION IS REQUIRED** to participate in the Birdies for Charity Contest or to become eligible to receive a prize. A pledge will not increase a participant’s likelihood of winning a prize.

2.) The Birdies for Charity Contest is open to all participants who are 18 years of age or older. The contest is void where prohibited or restricted by law. A participant need not be present to win.

3.) Only one (1) Grand Prize will be awarded. The Grand Prize will be awarded to the person who guesses the exact number of birdies made during the 2018 Rapiscan Systems Classic golf tournament. The guess may be any number. In the case of a tie, the Grand Prize winner will be chosen randomly by Rapiscan Systems Classic Officials from among those who correctly guess the exact number of birdies made. If no one guesses the exact number of birdies made, then the Grand Prize winner will be the person whose guess is the closest (without going over the total) to the actual number of birdies made during the tournament.

4.) The exact number of birdies made during the tournament will include all birdies made by the PGA TOUR Champion players at the 2019 Rapiscan Systems Classic tournament during official rounds, Friday through Sunday, and during playoff. It will not include birdies made on the Monday through Thursday at the Pro-Am event.

5.) Guesses for the Grand Prize will be taken up until Friday, March 29, 2019 at noon.

6.) PGA TOUR Champions Officials will determine the final number of birdies made.

7.) Only guesses made on official entry forms, including online forms, will be eligible for prizes. No exceptions. Additional entry forms may be obtained by contacting Mary

Wesche.

- 8.) The Judges' decisions and interpretations of these rules will be final and will be made in their sole and absolute discretion. No appeal of further review will be permitted. Rapiscan Systems Classic Officials will appoint the contest Judges.
- 9.) Prizes may not be exchanged for cash. A list of all prize winners may be obtained free of charge upon written request addressed to the tournament office.
- 10.) Winners are responsible for all sales taxes, registration fees, and INCOME TAXES on all prizes.
- 11.) Participants are limited to no more than 10 total guesses. Each guess must be on a separate pledge form or online entry form. If more than 10 guesses are received from any one participant, only the first 10 guesses received and recorded will be eligible for prizes.
- 12.) Directors, officers, and employees of the Rapiscan Systems Classic and the Bruno Event Team together with their families are not eligible for the Grand Prize.
- 13.) Clear, legible handwriting is the responsibility of all participants. The tournament shall not be responsible for any errors caused by poor penmanship.
- 14.) The tournament is not responsible for the "Guess the Birdies" guesses on entry forms received after Friday, March 29th at 12:00 PM CST of the tournament.
- 15.) These rules may be amended without notice at any time in the sole and absolute discretion of Rapiscan Systems Classic Officials.

Additional Information

- Pledges are tax deductible. Mississippi Gulf Resort Classic Foundation, Inc. is a 501(c)3 charitable organization.
- 100% of all collected pledges will go directly to the organization securing the pledge. No pledge funds will be used for overhead, program administration or prizes.
- No money collected goes to PGA TOUR Champions players.
- Your charity receives what is collected. If Rapiscan Systems Classic does not receive the pledge amount by the established deadline, your charity will not receive the donation. After the deadline, a listing of all uncollected pledges will be provided to each charity organization.
